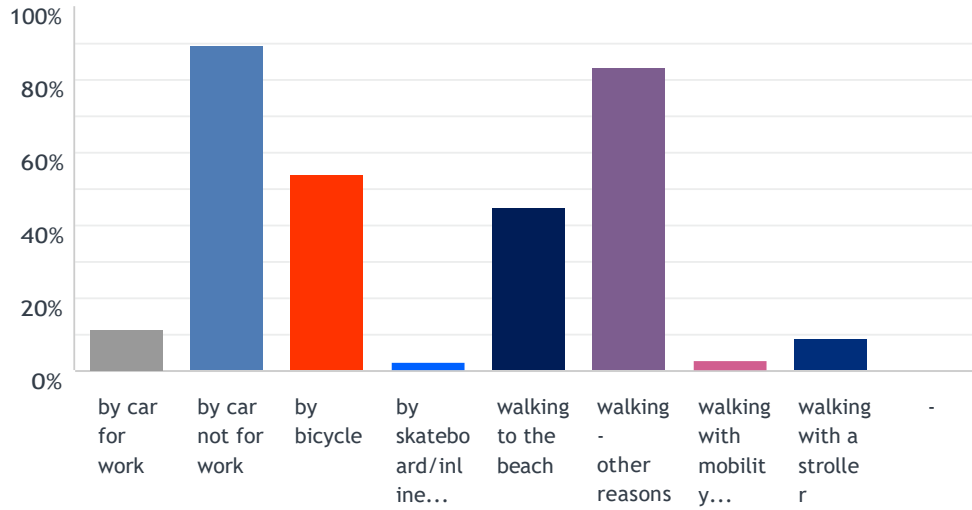

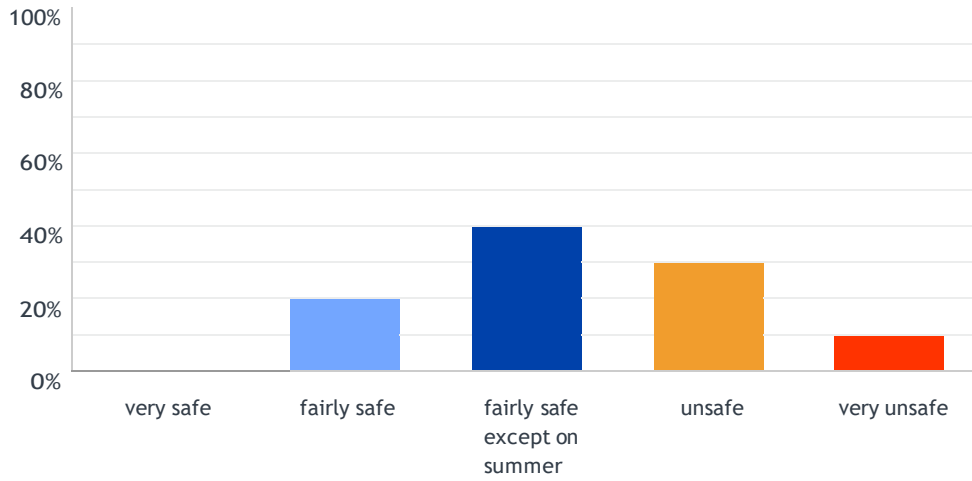

#	TELL US MORE ABOUT YOUR EXPERIENCES ON TBR:	DATE
1	There is very, very few that do the 40 km/hr on Tiny Beaches Road from the 4th Concession around the 90 degree turn to the 5th Concession. Many times we have seen cars pass one another with us walking on the side of the road where we have, had to move into the grassy areas to be safe. We are not quite seniors and can still move freely however those who cannot move quickly may one day get hit on a Summer Weekend! We have almost hit young kid drivers of mini-bikes and golf carts turning onto Nadia Street where there is several young children riding mini-bikes and go karts which only happens on weekends and usually after 4 p.m.!!	7/20/2020 10:50 PM
2	With more traffic on summer weekends, find that's when more vehicles seem to be passing by my place at a higher rate of speed than posted limit. Doesn't seem to be a problem rest of year.	7/19/2020 8:13 PM
3	The part of TBR used by my family and myself most often, when not driving, is the stretch between Nadia and Jones. This stretch , particularly by both of the bends: Jones and Trew Ave I consider to be extremely unsafe. For that reason, my family and myself is trying to avoid using TBR, but there are numerous situations when we have no other options. With a family member on the wheelchair to get to the accessible entrance to the beach on Trew Ave we need to use TBR (the chances of parking spot left are almost not existing). Pushing yourself on the wheelchair up the hill is quite a challenging task specially on the graveled or sandy shoulder, at times softened by the rain, therefor the wheelchair users are choosing to push on the paved road competing for space with speeding motorists. We need to remember that the possibility of so called close calls ending up with fatality for person on the wheelchair is much higher...no time to "run"... Crossing TBR, specially at the mentioned bends, where the visibility is greatly compromised I see as being very unsafe as well.	7/18/2020 10:38 PM
